Directions from 480 Westbound: Exit at the State Road/Oh-94 exit (16). Turn left (south) onto State Road. Turn right (west) onto Brookpark Road. Turn left (south) onto West 44<sup>th</sup> Street. Office is on the corner of West 44<sup>th</sup> Street and Brookpark Road. Parking lot is behind the building. Please enter through back door. Once inside, the Training Center is located through the 2<sup>nd</sup> door on the left.

Directions from the North: Take Jennings Freeway/OH-176 South to 480 West. Exit at the State Road/Oh-94 exit (16) then follow directions above.

Directions from 480 Eastbound: Exit at the State Road/Oh-94 exit (16). Turn right (south) onto State Road. Turn right (west) onto Brookpark Road. Turn left (south) onto West 44<sup>th</sup> Street.
